B. Parlow asked the member if she were receiving any income as a result of her injury, and she stated that she is only receiving social security. B. Farmer suggested she may wish to withdraw her Ordinary Disability Application as it does not benefit her monetarily and will be subject to workers' compensation offset.

Motion by B. Parlow, second by E. Mack to find sufficient medical evidence exists to forward the Accidental Disability Application to PERAC and to request that the Commission convene a regional medical panel.

DOROTHY M. BILOTTA – Superannuation to ADR Conversion – 2:05 P.M.

Attorney Erin M. Clasby of the Law Offices of James S. Aven representing.

Ms. Bilotta was superannuated in August 24, 2015. She subsequently applied for ADR, was accepted by the Board and approved by PERAC (May 2017) with an ADR effective date of April 26, 2016. Due to the retro-active date of her ADR retirement, it resulted in a workers' compensation offset; thus she owes the Board close to \$24,000. She came before the Board to ask that she be allowed to continue with her Superannuation and forego the ADR. Attorney Galvin advised that he could find nothing in the statue that allows this, and the Board felt that they could not do this as it was already accepted by PERAC and she owed the funds for the workers' compensation. Attorney Clasby asked if she could petition PERAC. Attorney Galvin felt that they would not get involved, however, the Board was inclined to give her more time to petition the agency if it was Bilotta's wish. B. Farmer warned that the longer the Board continues to pay her superannuation the more the workers' compensation offset debt would be. Attorney Clasby explained that Bilotta didn't have the funds to pay such a large offset and that it will take approximately six years for the Board to recoup the funds through her annuity that is not offset. B. Farmer suggested that if her compensation attorney could reach a settlement with the city which would cover the cost of the offset owed, she would be better off financially, as the ADR benefit is approximately \$12,000 more annually.

Attorney Galvin explained to the Applicant and his Attorney that 2 of the 3 physicians answered in the affirmative to all three questions, but one of the physicians questioned one of the surgeries performed and commented on the issue of permanency. Galvin explained the appeal process in the event that PERAC remands the application back to the Board.

He denied ever having a settlement, but Attorney McKenna stated that all prior workers' comp claims were provided to the City, however, Galvin stated that the Board was not privy to that but he agreed the City was provided those. McKenna stated Mulvey's last injury to the body part in question was in 2005; therefore, he would have been unable to perform the work that he has in the past decade. M. McLaughlin respectfully disagreed as different parts of the body will compensate for the injured part. McKenna stated this is a question for the medical panel to decide and the Board agreed, however, B. Farmer discussed that it is the Board's responsibility to reflect on causality.

E. Mack asked if he ever told any co-worker about his injury even in passing, to which the answer was in the negative. He did not mention his injury until he turned in his doctor's note in April.
