#### SEI

Terri Gerlich present to discuss Portfolio Status as of August 31, 2018

Gerlich began by stating that even though the key fundamentals such as corporate growth, job growth, high consumer spending and low unemployment exists, the market is not properly reflective of this. Intensifying trade tension, rising U.S. rate expectations and subpar reports outside of the U.S. were drags on the performance of most asset classes. Gerlich continued to state that in order to properly diversify and protect against the downside they are selling out of some fixed income holdings and moving to more intermediaries. The Structured Credit Fund and Energy Debt Fund performance helped the portfolio this quarter. He also advised that they are increasing the private equity program. He advised of certain management changes throughout the year and concluded that SEI is well diversified by asset class.
