SEI – Terry Gerlich – To discuss Q2 2019 performance and future outlook

Gerlich recalled that the Q418 Fed Reserve announcement to cut the rates caused some movement in the market, likewise the 0.25% cut this June resulted in domestic equities posting slightly positive while international and emerging markets slid due to signs of slowing global growth. The theme of his presentation was that there is still much volatility in the market with no clear signs of stability as any news headline can cause the market to react. Gerlich reviewed the diversification of the Brockton portfolio, and discussed the leaders and drags. The total portfolio YTD return is at 10.75% (11.75% SEI investments only) while the PRIT Fund Index is 10.26%. Most of BCRS legacies are in the ending stages, and almost drawn down; the real estate is rolling off. Gerlich remarked that they were approached by investors regarding the sale of the portfolio's holding in Sigular Guff as a secondary, however, SEI feels it is in the portfolio's best interest to hold. SEI continues to recommend that BCRS build up their private equity program.

NEW BUSINESS

Director is seeking clarification on the procedure for refunding supplemental pay while receiving worker's compensation to Accidental Disability Retirees.

Brockton has had many members on workers compensation throughout various periods of their career, and as such, they were paid supplemental pay (subject to pension deductions) each time. The PERAC Memos which discuss the Vernava decision instruct that the deductions on supplemental pay of sick and vacation should be refunded to the member in the event of an Accidental Disability award, however, these memos do not address whether this particular supplemental pay relates to the specific injury for which the member is awarded the Accidental Disability. The Director explained that to attempt to determine all workers' compensation supplemental pay in the distant past can be onerous, impractical and perhaps, even impossible if the pay records at that time were not automated. Counsel advised that in lieu of any specific guidance from a PERAC Memo regarding whether the refund should be given on the causal disabling injury the Board may advise on this procedure. The Board agreed that refunds will only be given on the supplemental pay for the injury or hazard for which the Accidental Disability was awarded.
