SEI - Terrence Gerlich present to review Performance Reports as of December 31, 2018 and 4th Ouarter

Gerlich reviewed the report with the Board which demonstrated a 4th Quarter flight to safety. While the market was experiencing positive returns in the first three quarters, the fourth quarter, especially the final month investors panicked. SEI realized a return of (6.03) compared to PRITs return of (1.83). Gerlich explained that these numbers can be deceptive as PRIT returns are reported on a lag, and the true effects of 4Q will be seen in PRITs future reports. Contributing to SEIs underperformance is the portfolio's lack of private equity, whereas PRIT has fully mature P/E programs. Member Farmer pointed out that even if Brockton had invested in PRITs P/E instead of SEI the Brockton portfolio still not realize the full PRIT return as their P/E investment would be as immature. Gerlich stated that up until 4Q SEI has been on par with PRITs performance. SEI's goal is to see another \$10M commitment in 2019 thus continuing to build up the P/E as fast as practicable. He pointed to SEI's Real Estate investment return which realized 8.9%, however, the R/E legacies dragged the overall strategy down to 4.41%. Going forward SEI sees no evidence of recession, however, they do feel overall growth is slowing. SEI will return in March.
