Terry Gerlich of SEI to join meeting

Gerlich stated that the market realized a substantial improvement in April and May, yet that gain was lost recently with the rising U.S. Covid 19 cases. Gerlich presented graphs demonstrating how the market has weathered bear markets over the last 50 years. While this pandemic is unprecedented bear markets certainly are not. SEI believes that value stock is the place to be even though the YTD numbers are not positive. They feel that this is a wonderful opportunity to buy value at low prices. Comparing SEI performance to PRIT he reminded the Board that PRIT numbers are always on a quarter lag. Gerlich discussed core property stating that BCRS is underweight in shopping centers and hotels which has helped the holding during the last quarter. Gerlich recommends an increase in real estate.
