Financials

Patrick Blizzard of SEI present to discuss portfolio performance, and cash distribution strategy

Blizzard presented the state of the portfolio as of April 30, 2023. His presentation demonstrated that U.S. equities had a strong start in January, retreated in February due to concerns over potential Federal Reserve increases, and fell further due to concerns about a credit crunch because of the Silicon Valley Bank failure. Blizzard noted that demographic shifts in US Population and the US federal government spending will have a lasting impact on the economy, as the aging population puts stress on pension plans and the rate of new participants is not keeping pace with rate of retirees.

The Board further discussed a cash reserve strategy but decided that they will stay on course at this time and maintain the current balance in the portfolio. They discussed the FY 2024 appropriation that will be coming in two weeks. There was much discussion on this with SEI and Fiducient. It was decided that the FY 2024 funds will be invested in a high yield cash vehicle with SEI rather than actively investing in the market.
